Experience

Arbitration cases

- Co-counsel in a Munich-seated ICC arbitration, representing an intergovernmental organisation in a
 dispute relating to the manufacture and supply of specialised equipment for the space industry. The
 amount in dispute is EUR 30 million. German law governs the dispute and the language of the arbitration
 is English.
- Co-counsel in an ad hoc arbitration, representing a national oil company in a dispute pertaining to the
 construction of a pipeline and the long-term supply of natural gas in the Middle East. The amount in
 dispute is in excess of USD 450 million, and the seat of arbitration is Paris (France). The applicable law is
 French law, and the language of the arbitration is English.
- Counsel in a mediation and ad hoc arbitration, representing a company in a dispute with its franchisor in the food distribution sector. The amount in dispute was EUR 2,5 million. French law and equity govern the dispute, and the language of the arbitration is French.

Pre-arbitral cases
